- Novice Rider – rider is in the 1st or 2nd year of showing and may show only in this class for 2 years maximum, on any horse
- Novice Horse – horse, with any rider, is in the 1st or 2nd year of showing and may show only in this class for 2 years maximum
- Junior rider – anyone who will have not reached the age of 21 prior to the end of 2009
